Declaration of result of voting through remote e-voting prior to and e-voting at 55th Annual General Meeting of The Indian Performing Right Society Limited held on 23rd September, 2025

In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, The Indian Performing Right Society Limited ('the Company') provided facility to the members for remote e-voting prior to and e- voting at the 55th Annual General Meeting held on 23rd September, 2025 (55th AGM) in respect of the resolutions vide the Notice dated 31st July, 2025 of 55th AGM (Notice) and Addendum to Notice dated 9th September, 2025, placed for the approval of Members of the Company.

The Board had appointed Mr. Himanshu S. Kamdar, Practicing Company Secretary, Partner of M/s Rathi & Associates, Company Secretaries, as the Scrutinizer to scrutinize process of remote e-voting prior to and e-voting at the 55th AGM of the Company.

The Scrutinizer considered voting done by members through remote e-voting during the period from 9.00 A.M. on Wednesday, 17th September, 2025 up to 5.00 P.M. on Monday, 22nd September, 2025 being the dates fixed for remote e-voting. Further, to enable those members who could not vote through remote e-voting prior to the 55th AGM, the Company provided facility to such members for voting through e-voting at the 55th AGM which commenced at 11.30 A.M. and concluded at 02.47 P.M.
