<u>Meeting of The Indian Performing Right Society Limited held on 30th December, 2020</u>

In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, **The Indian Performing Right Society Limited** ('the Company') provided facility to the members for remote e-voting prior to and e- voting at the 50th Annual General Meeting held on 30th December, 2020 (50th AGM) in respect of the resolutions vide the Notice dated 24th November, 2020 of 50th AGM, placed for the approval of Members of the Company.
